PERMIT AND RELEASE

FOR AND IN CONSIDERATION of _____ DOLLARS (\$) in hand paid, the receipt of which hereby acknowledged, PORT GRAHAM CORPORATION does with these presents, permit _____ to enter upon lands described herein below for the purpose of sightseeing, fishing, and camping for _____ twenty-four (24) hour period(s). All other uses of said lands are strictly prohibited and any other use or attempted use will cause immediate revocation of the license herein granted. Provided, however, that upon the expiration of this License, the same is immediately revoked.

NOTICE: _____, hereinafter "Licensee," does, for himself/herself, and for any minor children over whom is acting as guardian upon the premises, agree to indemnify, defend, and save harmless PORT GRAHAM CORPORATION from all injuries, damages, and the like, which Licensee may suffer from any person or persons whatsoever, including but not limited to acts of violence by third persons directed against Licensee and Licensee's minor children upon the premises herein, accidental death, dismemberment, and/or injury to any bodily organ of Licensee.

Licensee does, in consideration of the Licensee herein granted for himself/herself and any minor children who accompany Licensee upon the premises over whom Licensee is acting as guardian, release and discharge, and acquit, and forever discharge PORT GRAHAM CORPORATION and its successor in interest and assigns, of and from all actions, causes of action, suits, controversies, claims, damages, costs, loss of use, liens, loss of services, expenses, lost earnings, incurred or to be incurred, compensation, consequential damages, prejudgement interest, post settlement interest, attorneys' fees, litigation costs and demands of every kind and nature whatsoever on account of or in any growing out of any injury or injuries which Licensee and/or minor children accompanying Licensee over whom Licensee is acting as guardian while upon the lands of PORT GRAHAM CORPORATION.

Licensee shall exercise the privileges hereunder granted at Licensee's own risk.

Licensee shall comply with all rules and regulations, federal, state and those of the land owner, relating to use of the real property, and shall take all reasonable precautions to prevent or suppress fires thereon.
